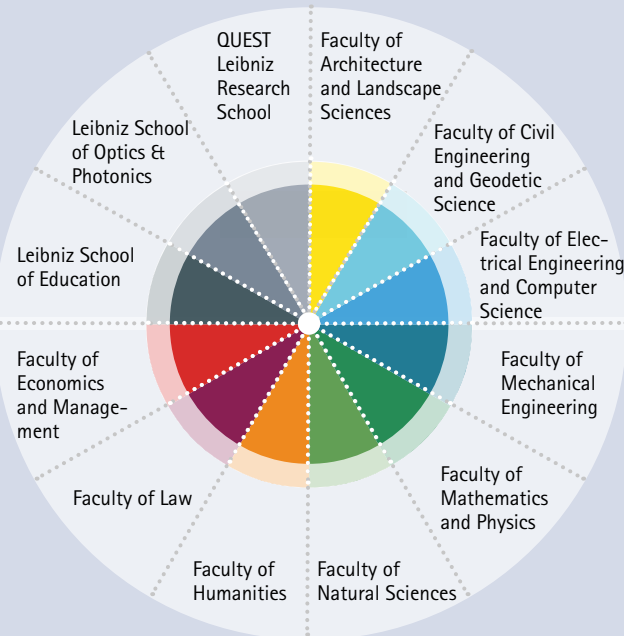

## University bodies according to Lower Saxony higher education laws (NHG)

Presidential Board:

Management of the university, as well as decisions regarding all matters that are not assigned to other bodies by higher education regulations (NHG). This includes target agreements with the State, legal supervision of university bodies, the student body and organisation of university development

Senate:

Decisions regarding university regulations, if not assigned to other university bodies, decisions regarding the development plan (the basis for target agreements) and the equality plan in agreement with the presidential board, statements concerning fundamentally important matters of self-governing, recommendations for the appointment of the President and Vice President for Finance and Administration

Dean's office:

Faculty management, enforcing decisions made by the faculty board and accountability to the faculty board

Faculty board:

Decisions regarding fundamentally important matters concerning teaching and research, decisions regarding faculty regulations
